APPLICANT: Heimpel Design (Mark Heimpel) for Maitland Welding (91452 Ontario Inc)

LOCATION OF PROPERTY: 63 North Street, Wingham, Ontario NOG 2W0

EXISTING ZONING BY-LAW PROVISIONS & OFFICIAL PLAN DESIGNATION: The property is zoned VC2 (Highway Commercial) and is designated Highway Commercial.

PURPOSE OF APPLICATION: To allow for the expansion of an existing steel fabrication shop (Maitland Welding) that has legal non-conforming status. This application also proposes to reduce the required rear yard setback and increase the maximum lot coverage permitted within the Morris-Turnberry Zoning By-law. See attached site plan and location map.

PROPOSED APPLICATIONS:

- 1.) Allow for the expansion of an existing legal non-conforming use subject to Section 45 (2)(a)(i) of the Planning Act R.S.O. 1990;
- 2.) Proposed relief from Section 19.3.6 of Morris-Turnberry Zoning By-Law 45-2014 to reduce the required rear yard setback from 7.5m to 3.5m;
- 3.) Proposed relief from Section 19.3.7 of Morris-Turnberry Zoning By-Law By- law 45-2014 to increase the maximum lot coverage from the required 25 to 30 percent.
