7.2.2 Gravel Road Complaints

At the request of Deputy Mayor Zinn, a report was presented by Director of Public Works Mike Alcock regarding complaints of excess gravel in ditches for the information of Council.

Deputy Mayor Zinn thanked Mr. Alcock for his detailed report. She noted that while there was no solution presented in the report for the complaints that she has received, there is good information share.

Mr. Alcock reminded Council that that if complaints are received or they are notified of a hazardous situation it can be brought to the attention of staff for action.

Councillor Nelemans that the introduction of the 4% crown on gravel roads has been an improvement. He noted that during a previous term of Council a delegation came complaining of standing water on some roads, and that has since been resolved.

8.0 BUSINESS

8.1 Cross Border Negotiations Correspondence

A report was presented by CAO/Clerk Trevor Hallam in this regard.

Mayor Heffer suggested that it would be wise to ask for a Chair for the meeting that does not sit on the committee, explaining that it would be an appropriate measure to keep the committee on track. He suggested the current or a past warden from the County, or someone with some facilitation experience like Wayne Caldwell.

Councillor Nelemans agreed with having a third-party Chair, noting that it should be someone who understands water systems, not necessarily someone from the public. He said he was not sure the committee could resolve all the issues in one day, but that he did think that they could reach water and sewer agreement all in one day, and deal with the rest after.

Councillor Freiburger said he was not familiar with Mr. Caldwell but is aware that current Warden is supportive of the two sides finding a resolution and believes he would approach this fairly.

Mayor Heffer followed up on Councillor Nelemans' comment stating that members of the public have reached out to him and have offered to help but it that he thought it needs to be someone with a bit more distance from the situation.

Councillor Nelemans agreed adding that someone from the public would have to understand that it's a user pay system, and if it's not it won't' work. He agreed the Warden would be suitable.

Heffer summarized that staff should first check with those individuals discussed to gauge their willingness and then confirm with the Morris-Turnberry members of the committee to find potential dates to propose to expedite the process, after which a response with that information can be sent to North Huron.

Deputy Mayor Zinn agreed with the suggested names for Chair and emphasized that this should be done quickly to avoid any further delays.

Councillor McCallum noted that he is in favour of the course of action discussed as well.

Direction was given to staff to proceed as discussed.

8.2 Service Line Warranties Canada Mailing

A report was presented by CAO/Clerk Trevor Hallam in this regard.

Councillor Nelemans comment that the materials looked good.
