5.0 BUSINESS

5.1 HOUSING FRIENDLY DEVELOPMENT REVIEW

At the March 2nd, 2021, meeting of Council, the Huron County Planning department shared information concerning ongoing consultations with respect to ensuring that the planning framework is designed to facilitate the building of residential units to meet future and current needs.

Ms. Van Amersfoort introduced the housing friendly review process that lower tier municipalities are undertaking and asked Council and staff for their input regarding the housing related issues they are hearing in the community. These included:

- · Housing supply, more housing is needed and quickly
- · Housing prices are too high and inaccessible to younger people
- Regulations and study requirements to develop are too burdensome and causing long delays in the development process
- The speed at which the planning process moves.
- Cost cap for the Huron County home ownership program hasn't kept up with the increases of house values.
- Potential for residential use of marginal agriculture lands not being explored.
- Increased demand for higher density development but issues and limitations with having multi-unit residences on shared private services.

Ms. Van Amersfoort reviewed the current policy framework in Morris-Turnberry for housing and introduced potential changes designed to deliver the housing units needed to meet present and future needs the community including:

In agricultural areas:

- Permitting a second permanent dwelling on AG1 parcels (50 acres or greater in size) within set distance of building cluster as opposed to main dwelling;
- Permitting bunkhouses or similar secondary units in a cluster of small buildings with shared services rather than one, large building on AG1 and AG3 parcels;
- Permitting an additional residential unit attached to a main building on AG4
 Parcels, with detached residences continuing to follow the current garden suite
 provisions.

In settlement areas:

- Including policies which support development of full range of housing options (tenure, affordability, special needs, size, type);
- Clarifying the intent of the word 'compatible': development or redevelopment
 which may not necessarily be the same as or similar to the existing development
 in the vicinity, but shall enhance the character of the community, while not
 creating any undue, adverse impacts on adjacent properties;
- Updating definitions;
- Removing minimum area requirements to be dictated by Building Code moving forward;
- Clarifying requirements and process for multi-unit buildings and additional residential units.

Discussion ensued and Council expressed some concern with continuing to allow garden suites on AG4 Parcels, due to the issues they have experienced regarding the tenure of such dwellings and the issues related to misconceptions or misunderstandings about what is temporary.

Ms. Van Amersfoort identified potential next steps, including receiving direction from Council to move forward with some of the changes proposed, reviewing the current Zoning By-law and Official Plan and recommending amendments for Council's consideration, and a public consultation process regarding the changes should Council wish to move forward.
